In order to present a variety of artists and their work, participation is limited to no more than eight (8) assorted Saturdays in the season. **The fee per market will be \$25.00, payable to Riverwalk Landing Business Association (RLBA), along with your application, including representative pictures of your work, and hold harmless agreement.** Should additional space become available for markets in which you are NOT scheduled, the Artist Liaison may offer you an opportunity to exhibit at a cost of **\$20.00** for that market. Artists are required to be in attendance at all times during the markets. Should the market be canceled due to inclement weather, artists will be scheduled for another date if possible (**NO REFUNDS**). If you are a new artist, please email pictures of your work to the artist liaison for approval prior to sending in application. If you are applying late in the season, please check with the artist liaison on availability of dates you are interested in prior to sending in application.

## **OPERATING HOURS**

Yorktown Market Days operates rain or shine and is open from **8 am to 12 pm April – Oct, with extended hours of 8 am to 3 pm on Aug. 15, Sept. 19 and Oct10, and 9 am to 3 pm Oct. 31, Nov 14 & 21 and Dec 12.**

The exhibit area will be at the performance stage area across from the main market area; space is sufficient for two artists to display under the tent on the stage, and additional space is available on the grass area in front of the stage. The stage spaces will be assigned on a first-come basis and may not be available on some themed festival markets; if displaying on the grass area, it will be necessary for the artist to provide his/her own tent. It's also necessary for artists to provide his/her "wall" space.

Artists can arrive at 7:00am. Artists to be set-up and ready for business no later than 8:00am. All vehicles must be out of the Market area by this time and will be strictly enforced. Contact Artist Liaison for more details.

Artists are required to park in designated parking at York Hall or the County Administration building, both located on Ballard Street. A free trolley begins running at 10 am and will be available to transport artists back to their vehicles at the conclusion of the market at 12 pm. **NO ARTISTS are permitted to park on either level of the Riverwalk Landing Parking Terrace.**

Please check here if you will be using a truck w/trailer for unloading and loading

At the conclusion of each Market at 12pm (and 3 pm on select days), artists are required to breakdown their booth and clear the area no later than 1 hour after the end of the market. Contact Artist Liaison for more details on set up and break down.

- ❖ Vendors/Artists must participate in production of the product they sell.
- ❖ Re-selling of purchased items is strictly prohibited.
- ❖ Sale of crafts, manufactured, used or imported goods is not permitted.

Yorktown Market Days assumes no responsibility for any loss or damage that may occur to the work of the artists. **A York County Business License is required and must be shown to the Artist Liaison on the first day of participation at the market.** Exhibiting artists are reminded that sales tax in Virginia is **7%**. Yorktown Market Days accepts no responsibility for the proper collection of appropriate taxes.
